CITY COUNCIL MEETING
MAY 17, 1993

6:00 P.M. - CLOSED SESSION: This time has been set aside for the City Council to meet in closed session to discuss matters pertaining to litigation (pursuant to Government Code Section 54956.9(a)), potential litigation (pursuant to Government Code Section 54956.9(b) and (c)), personnel, and/or claims. The Mayor or the City Attorney will give an additional oral report of the closed session at the commencement of the public portion of the meeting.

7:00 P.M. - REGULAR MEETING

CALL TO ORDER: Mayor Guarriello called the meeting to order at 7:00 p.m.

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Mike Radcliffe.

ROLL CALL: PRESENT: Heilman, Koretz, Land, Lang, and Mayor Guarriello

ALSO PRESENT: City Manager Brotzman
City Attorney Jenkins

REPORT OF CLOSED SESSION: City Attorney Jenkins reported that the Council had convened to Closed Session at 6:52 p.m. and approved the claim of Mike Broukian. Motion Heilman second Guarriello. Hearing no objection it was so ordered.

APPROVAL OF AGENDA: ACTION: Add an urgency item to the Agenda under Unfinished Business, which arose after the agenda had been posted, regarding dissemination of information for a single zip code for the City of West Hollywood. Motion Land second Heilman. Hearing no objection it was so ordered.

FURTHER ACTION: Move Item 8 to Consent Calendar. Table 2d, approval of May 3 minutes, to next meeting. Approve agenda as amended. Motion Heilman second Land. Hearing no objection it was so ordered.

PROCLAMATIONS AND COMMENDATIONS:

Mayor Guarriello presented a plaque to David Mitchell of Human Services Department, the City of West Hollywood "Employee of the Year" for 1992.

Captain Clarence Chapman of the Sheriff's Department presented a "Citizen of the Quarter" commendation to Lisa Elaine Comshaw, signed by Sheriff Sherman Block, for Ms. Comshaw's actions in

assisting Sheriff's deputies to apprehend a purse snatcher.

Mayor Pro Tem Land announced the West Hollywood Exhibition of the AIDS Memorial Quilt, to be held on October 8,9 and 10 at the Pacific Design Center, and announced that pieces of the Quilt are on display in the auditorium tonight. Commendations were presented to Norma Pierson and Jeff Wallace, volunteers from the Names Project Los Angeles, who coordinated the Quilt Exhibition in West Hollywood. Jeff Wallace gave comments on how the Quilt Exhibition was brought to West Hollywood, the title of the display--"People Do Care, West Hollywood Display of the AIDS Memorial Quilt", and the selection of beneficiaries of the display.

CITY MANAGER'S REPORT: This time has been set aside for the City Manager to update the Council on important items initiated by staff or previously requested by the City Council. City Manager Brotzman commented on the public information table at the entry door to the auditorium; this was a result of the Excellence in Service Task Force that was initiated by Mayor Pro Tem Land, with a number of City employees.

The City Manager announced that the City had received an award from the Western Governmental Research Association for a paper completed by Elizabeth Murphy, an intern, dealing with the issue of insurance for domestic partners. Two City of West Hollywood cable programs--1) "Get Used to It", a gay and lesbian program; and 2) "Crime Watch", a crime prevention show--were nominated for awards at the Hometown Video Festival, and will be judged in the next few weeks; these were from over 2,020 entries from over 420 cities in 40 states and five Canadian provinces.

1. CITIZEN COMMENTS: This time has been set aside for members of the public to address the City Council on Consent Calendar items, other agenda items if the member of the public cannot be present later in the meeting at the time the item is heard by the Council, and items of general interest. Testimony for public hearings will only be taken at the time of the hearing. This period shall be limited to 20 minutes, with no more than two minutes for each speaker.

Mike Radcliffe, Los Angeles, President, West Hollywood Community Alliance: Thanked people who attended our reception for Hahn. The Alliance will be handing out forms to commercial property owners to help devalue their properties. June 16th is annual meeting of the Alliance. Regarding the East End Revitalization Plan--we will be conducting a door to door survey over next three weeks to help Community Development Department determine how much support there is for some of the recommendations. The Alliance is seeking donations from the business community to help the District Attorney provide brochures for the gay pride event in June--it will be a brochure on hate crimes.

Tim Olson, West Hollywood: W.H. Citizens for Better Police Protection. In support of the reverse sting operation to combat gay bashing. We need visible police presence in high crime areas on a regular basis; ask that there be two deputies each Friday and Saturday night to walk the beat on Santa Monica Boulevard.

Bruce Traub, West Hollywood: Opposed to utility tax. Increased taxes are proposed on a Federal, State, County level. Eighty-four percent of West Hollywood residents make under \$30,000 yet median of City employees is \$35,000.

Kevin Notre, West Hollywood: Develop an umbrella needs test for all social service programs.

Charlie Mercer, Sunset Strip Association, West Hollywood: Committee for Fiscal Responsibility. Looked at the preliminary budget--am shocked that utility tax is included in the budget. We feel the budget can be balanced without the utility tax. We will again present a written proposal on May 21st, as requested by City Manager. The budget is \$36 million. What have we got for our money?

Donny Cacy, West Hollywood: Regarding pay phones on Santa Monica Blvd. Fred Mashion of Golden rule liquor is responsible. Two phones on each block is plenty; have no incoming calls and phones shut off at 9:00 p.m. Let's adopt an ordinance.

h. Renewal of General Liability Insurance Coverage:

ACTION: Authorize the City Manager to sign the contract with Insurance Company of the West for General Liability at a self-insured retention (the self-insured retention is that part of a claim which the City must pay before the insurance is used - the "deductible", in effect) of \$150,000 with coverage to \$10,000,000 at a premium of \$148,620.

i. Renewal of Crime Insurance Coverage: ACTION: Authorize

the expenditure of \$26,000 to bind coverage of a \$1,000,000 crime insurance policy.

8. SOCIAL SERVICES PROVIDERS MIDYEAR REPORT: THIS ITEM WAS MOVED TO CONSENT CALENDAR UNDER APPROVAL OF AGENDA. ACTION: Receive and file the Report and approve probationary recommendations. Approved as part of the Consent Calendar.

COUNCILMEMBER COMMENTS: This portion of the meeting shall be set aside for general comments, announcements, requests of staff, and/or other issues of concern from members of the City Council. Mayor Guarriello commented that California is the last State in regard to economic recovery, and the Council will do their best in making budget decisions in the toughest of economic times that the City has faced.

Councilmember Lang, in response to a citizen comment, stated that low-income persons are exempt from taxes in the City, including utility tax. Low-income persons also do not have their taxi coupon fee raised. Councilmember Lang also mentioned some of the things the City has accomplished in the last five years: an adult day care center on Santa Monica Boulevard; the homeless organization; the City shuttle. These are just three things that budget money has gone to.

Councilmember Heilman said that he believes the budget comparison between 1988 and the present, that was quoted by one of the public speakers, was inaccurate.

City Manager Brotzman said that he could confirm that the comparison was inaccurate; he will provide accurate figures to Council.

Councilmember Land encouraged everyone to visit the AIDS Memorial at Hart Park during Memorial Day weekend; thanked Richard Settle, photographer, and James Litz, Planning Commissioner, for reminding her. They will be at Hart Park over the weekend to keep the Memorial clean and accessible.

Councilmember Koretz commented that he is concerned about the West Hollywood budget, but even more so about the County budget; he encouraged people to write to State Senator Tom Hayden and Assemblyman Burt Margolin and our local legislators. Prisoners are being released in L.A. County, as a result of budget cuts. There needs to be a concerted effort to save County services because of cuts at the State level.

UNFINISHED BUSINESS

3. PROPOSED AMENDMENT TO MUNICIPAL CODE REGARDING SMOKING IN PUBLIC PLACES AND PLACES OF EMPLOYMENT: Councilmember Koretz reported that he had brought this Item to Council because of the growing evidence of the dangers of secondhand smoke; restaurant workers are primary victims. The question has been how to ban smoking in restaurants without losing business. When Beverly Hills passed a 100 percent ban, there was a perception of lost business. This ordinance would be written in such a way that it would only be enforced when the neighboring cities put a similar ordinance into effect. It is a first step of what is being proposed at a State level. Councilmember Koretz also noted, for the record, that he had worked in the field of Workers'

Compensation, and so has some awareness of this issue.

The following person came forward to address the City Council:
Mike Radcliffe, West Hollywood: Support the no-smoking ban in restaurants only if it is approved State-wide.

Mayor Guarriello asked why bars and nightclubs were excluded from the proposed smoking ban. Councilmember Koretz said that as a practical matter, people have a greater expectation of smoking in bars.

ACTION: Direct the City Attorney to prepare an amendment to Chapter VI of Article IV of the West Hollywood Municipal Code to incorporate the following changes and return to Council for consideration at the regular Council meeting on July 6, 1993:
a) Add "Restaurants" either to the list of public places or places of employment where smoking is prohibited, whichever the City Attorney deems more appropriate; b) Continue to exclude "nightclubs, bars and privately rented rooms" from the list of public places where smoking is prohibited; c) Make these changes effective upon the adoption of similar measures by the cities of Los Angeles, Beverly Hills, and Santa Monica.
Motion Lang second Heilman.

AYES: Heilman, Koretz, Land, Lang

NOES: None

ABSTAIN: Guarriello (Noted that he was abstaining until all the situations--bars, cocktail lounges, etc.--are included in the places where smoking is prohibited.)
Motion carried.

3-A. DISSEMINATION OF INFORMATION REGARDING SINGLE ZIP CODE:

(THIS ITEM WAS ADDED AS URGENCY ITEM UNDER APPROVAL OF AGENDA, BY A UNANIMOUS VOTE.) Councilmember Land reported that there have been negotiations since February of 1992 with the Post Office, for a single zip code for the City of West Hollywood; finally there is a process that allows cities to request a single zip code designation. The Post Office will be sending out a ballot the first week of June, asking people if they would like to have the single zip code designation of 90069. This item is asking for approval to mail out an informational letter to residents prior to the ballot going out.

ACTION: 1) Approve the mailing of a letter to residents and businesses regarding the potential of the City's being assigned a single ZIP Code. 2) Direct staff to create the letter and mail it at the earliest possible date. Motion Land second Lang.
Hearing no objection it was so ordered.

NEW BUSINESS

4. RESOLUTION IN SUPPORT OF IMMUNITY FOR MEMBERS OF THE MILITARY SERVICE FOR PURPOSES OF TESTIMONY: Councilmember Heilman reported that this Resolution would put the City Council on record in support of granting immunity to those members of the Armed

Services who testify at any of the hearings in relation to lifting the ban on gays and lesbians serving in the military. Under the current policy, if a member of the armed services comes forward to testify about the ban, that person will potentially be discharged. ACTION: Adopt Resolution No. 1140, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD SUPPORTING THE GRANTING OF IMMUNITY FOR GAY AND LESBIAN MEMBERS OF THE MILITARY SERVICE FOR THE PURPOSES OF GIVING TESTIMONY"; 2) Direct staff to provide a copy of Resolution No. 1140 to the President of the United States and all members of both the Senate and House Armed Services Committees chaired by Senator Sam Nunn and Representative Ronald Dellums, respectively, and to Senators Dianne Feinstein and Barbara Boxer and to Representative Henry Waxman. Motion Lang second Heilman. Hearing no objection it was so ordered.

5. RESOLUTION CONDEMNING RACIST AND DISCRIMINATORY CAMPAIGN PRACTICES: Councilmember Heilman reported on this Item. He stated that he is personally opposed to the Initiative on the ballot, and does not want to be associated with this (racist) campaign practice; thanked all the people both pro and con who have come forward against this. The person responsible was not from West Hollywood.

The following persons came forward to address the City Council: Adam Devejian, West Hollywood: Racism has no place in West Hollywood; we have formed a No on Prop. D committee--our first action was to oppose racist campaigning. Mike Radcliffe, West Hollywood Community Alliance: In support of this Item. Hope you will pass an ethics law where people have to divulge who they are. Support the Card Club Initiative. John duran, West Hollywood: Thank you for having the Quilt Panels here. Don't think the Council can prohibit racism, but we can stand united against this kind of activity. Suggest Council may wish to expand scope of Human Services Commission to looking into issues like this.

ACTION: 1) Adopt Resolution No. 1141, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD CONDEMNING RACIST AND DISCRIMINATORY CAMPAIGN PRACTICES"; 2) Direct staff to provide a copy of Resolution No. 1141 to any and all parties identified with any such practices and to the Fair Political Practices Commission. Motion Heilman second Guarriello. Hearing no objection it was so ordered.

6. REVERSE STING OPERATION TO COMBAT GAY BASHING AND HATE CRIMES: Nancy Greenstein, Public Safety Officer, gave the staff report.

The following persons came forward to address the City Council: Kevin Notre, West Hollywood: In support of the sting operation and the TEAMS project. John Duran, West Hollywood: Thanked Nancy Greenstein and Capt. Chapman for this Item. However, suggest two caveats: one, that the officers must have sensitivity with respect to the gay men on

Santa Monica Boulevard. There must be education to make sure that people understand the deputies are there to help; secondly, there was a story in the L.A. Times that discussed having the officers "act gay"--how are they going to "act gay"? They should be sensitive that there are no stereotypes being played into.

Howard Armistead, West Hollywood: I have seven points about this proposal: 1) We are copying a program in Long Beach that has operated two years, without a single arrest. 2) This is a publicity gimmick. 3) This has made a mockery of West Hollywood. 4) Long Beach is very different than West Hollywood; in Long Beach bashings happened in one little area; pedestrian traffic is greater in West Hollywood. 5) West Hollywood needs a rapid response team for gay bashings, and education and guidelines for entire Sheriff's Department. 6) Streets will never be policed as they should without our own Police Department, and Sheriff's Department ends blatant discrimination against gays and lesbians. 7) Suggest we put officers out on the street in their uniforms--enhance visible presence.

Paul Amirault, West Hollywood: West Hollywood Citizens for Better Police Protection. Fully support.

Councilmember Heilman commented that he was at the forum on gay bashing, and it was very well received by the public; the statistics from Long Beach were that the incidents did decrease; doesn't view this as a gimmick, views it as real policing; agree that Long Beach and West Hollywood are different communities. Hope the community will continue to work with the Department; encourage people to report these incidents.

Councilmember Koretz spoke in support of the sting operation, and suggested increased visibility of the Sheriff's Department on nights when they are not doing the reverse sting operation.

ACTION: 1) Direct the City Manager to have the Sheriff's Department begin the necessary training and planning to implement a Reverse Sting program to begin in the summer of 1993; 2) Direct the City Manager to have Sheriff's and Public Safety staff recruit community volunteers to train and provide expertise on the lesbian and gay community to the Sheriff's deputies in the reverse sting; 3) Encourage community members to organize a TEAMS program to work in conjunction with the Sheriff's Department and Public Safety Division; 4) Direct staff to prepare a report and evaluation of the project at the end of the summer; 5) In addition, look at enforcement and increasing visibility of Sheriff's Department, as suggested by Councilmember Koretz. Motion Land second Heilman.

AYES: Heilman, Koretz, Land, Lang, Guarriello.
NOES: None.
Motion carried.

Captain Chapman stated that they would get started tomorrow on the project, and would have something for review before the end of June.

7. PACIFIC BELL NEGOTIATIONS: Mayor Pro Tem Land reported on the

results of negotiations with Pacific Bell: The phone company has offered to provide stickers with the Sheriff's Department phone number, which people can place on their phone. Companies can change their listing to West Hollywood if they wish. All the 310 and 213 West Hollywood numbers will be listed in one phone book. West Hollywood will be placed on all the maps. The telephone company will research changing its intercept messages to indicate that the person may have dialed an incorrect area code. The phone company will work with the City for a long distance directory assistance.

ACTION: 1) Receive and file the results of the negotiations listed in the "Background/Analysis" section; 2) Give specific direction regarding changing West Hollywood phone numbers currently listed in phone directories as "Los Angeles" to "West Hollywood." Motion Land second Heilman. Hearing no objection it was so ordered.

(ITEM 8, SOCIAL SERVICES PROVIDERS MIDYEAR REPORT, WAS MOVED TO CONSENT CALENDAR AND APPROVED AS PART OF THE CONSENT CALENDAR.)

EXCLUDED CONSENT CALENDAR: Items removed from the Consent Calendar for separate discussion shall be considered at this time. There were no items pulled for separate discussion.

CITIZEN COMMENTS: This time has been set aside for the public to address the Council on any item of interest that could not be heard under Item 1 at the beginning of the meeting.

The following person came forward to address the City Council: Norma Pierson, Sierra Madre: Member of the Quilt Display Committee--we are proud to have panel-making workshop opening in the City of West Hollywood beginning June 2nd, at 8252 1/2 Santa Monica Boulevard. All types of panels will be able to be made.

9. ORDINANCE ALLOWING BARS AND NIGHTCLUBS TO REMAIN OPEN UNTIL 4:00 A.M.
