CALL TO ORDER: Mayor Lang called the meeting to order at 7:30 p.m.

REPORT ON CLOSED SESSION: City Attorney Jenkins reported that the City Council met in closed session at 6:00 p.m. to discuss matters pertaining to labor negotiations and direction was given to the City negotiator.

Motion Land second Koretz. Hearing no objection it was so ordered. **FURTHER ACTION:** Add an emergency appointment to Rent Stabilization Commission by Mayor Lang to Item no. 7. Motion Koretz second Land. Hearing no objection it was so ordered. Approve the agenda as amended. Motion Land second Guarriello. Hearing no objection it was so ordered.

CITY MANAGER'S REPORT: This time has been set aside for the City Manager to update the Council on important items initiated by staff or previously requested by the City Council. City Manager Brotzman reported on the transition in parking enforcement, from the County to a private contractor; the State budget and two items could affect the City--one is the direct loss of revenue to the City and two, it is extremely likely the fire districts will have a substantial loss; and third, the Kolts report and the Sheriff's Department.

At this point in time, Item 10, Bosnia-Herzegovina, was heard by the Council, but is listed in its original position for clarity.

1. City Attorney Jenkins replied to Koretz regarding what Fairchild objected to. "assume all liability for conduct of its police officers." He objected that the City could buy insurance and therefore it's misleading. Objected to the phrase "any additional funding". 8. PRODUCE VENDORS AND STREET PEDDLERS CAUSING NUISANCES AT PLUMMER PARK AND ON COMMERCIAL STREETS: The staff report was given by Sue Wilcox and Anne Browning. ACTION: On the street peddler problem, direct staff to work a minimum of five hours per week for the next month on peddler issue on Santa Monica Blvd. to give priority to immediate response to business owners and to ascertain whether enforcement coupled with information to businesses to post "No Soliciting" signs can solve the problems; direct staff to continue current practices regarding issuance of Business License and to work with Russian Community Center to set workshops to listen to the needs of the Russian Community and determine solutions; meet with produce vendors and local businesses around Plummer Park, Farmers' Market people, and discuss their needs and ways to come to positive solutions; follow-up report in October. 
