CALL TO ORDER: Mayor Viterbi called the meeting to order at 7:14 P.M.

1. CANVASS OF THE ELECTION OF APRIL 12, 1988: ACTION: To approve and adopt Resolution No. 426, "A RESOLUTION OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 1988, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW." Motion Heilman second Schulte. Hearing no objection and noting the absence of Albert, it was so ordered.

REMARKS BY MAYOR VITERBI: Mayor Viterbi spoke about the accomplishments of the City Council and his contributions since the formation of the City merely 3 1/2 years ago.

PRESENTATIONS: Councilmember Heilman presented a plaque of appreciation to the Mayor, and Councilmembers Schulte and Land also addressed remarks to Mayor Viterbi on his retirement from the Council.

Mayor Viterbi left the stage and the meeting was turned over to the City Clerk.

2. SWEARING IN OF COUNCILMEMBERS BY CITY CLERK Mary Tyson, City Clerk, administered the Oath of office to Abbe Land and then administered the Oath of office to Paul Koretz, who were both then given their Certificates of Election and seated on the Council.

Both Councilmember Land and Councilmember Koretz made remarks about the election and thanked their friends and supporters. Councilmember Koretz made a presentation to former Mayor Viterbi on behalf of Business License Commissioner Lester Hirsch, citing the Mayor as one of the outstanding Physics students of the year, which was greeted with laughter and good humor.

RESOLUTION NO. 426

A RESOLUTION OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 1988, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of West Hollywood, California, on Tuesday, April 12, 1988, as required by law; and

WHEREAS, notice of election was given in time, form and manner as provided by law, that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the City Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the City except absent voter ballots was 5,037.

SECTION 2. The names of persons voted for at the election for Member of the City Council are as follows:

Paul Koretz
Teresa Garay
Abbe Land
Ruth Williams

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective office for which the persons were candidates were as listed in "Exhibit A" attached.

SECTION 4. The City Council does declare and determine that:

Abbe Land was elected as Member of the City Council for the full term of four years;


Paul Koretz was elected as Member of the City Council for the full term of four years.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the results of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; (5) The total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.


SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
