Regulatory Business License Application Process



Neighborhood and Business Safety Division

The City of West Hollywood requires 34 business types to obtain a Regulatory Business License. [Click here](#) for a comprehensive list.

If your business type is not reflected in the list above, you do **NOT** need to apply for a business license. However, all businesses require a Tax Certificate. Please refer to Step 3 for more information.

If your business type does require a business license, please complete the steps below.

Note: Application requirements may vary based on business type.

1 OBTAIN BUSINESS LICENSE APPLICATION

To obtain an application, visit the City of West Hollywood's [Business License webpage](#). You may apply via the City's Online Permit and License Portal at: <https://cityofwesthollywoodca-energovweb.tylerhost.net/apps/selfservice#/home>.

You must submit an application for each corresponding business type. Businesses may require multiple business licenses. *For example: A nightclub with dancing or live entertainment requires two business license applications.*

2 CURRENT & HISTORIC PRESERVATION PLANNING DIVISION- LAND USE PERMITS

Store front businesses should first consult the City's Current & Historic Planning Division to ensure their business use and location adhere to City zoning requirements.

Store front businesses must contact the City's Building & Safety Division to schedule a business license inspection.

Store front businesses must contact the Los Angeles County Fire Department, Fire Prevention Division to schedule a business license inspection.

6 LOS ANGELES COUNTY DEPARTMENT OF PUBLIC HEALTH (If Applicable)

Public Eating and Public Eating with Alcohol establishments must contact the Los Angeles County Department of Public Health for approval.

7 LOS ANGELES COUNTY SHERIFF'S DEPARTMENT (If Applicable)

Massage Parlor and Fortuneteller establishments must contact the Los Angeles County Sheriff's Department for a background check and approval.

8 NEIGHBORHOOD AND BUSINESS SAFETY DIVISION - SUBMITTAL

Once your application is complete, submit to the Neighborhood and Business Safety Division. All approvals must be signed by the respective agency. **Incomplete applications will not be reviewed.**
